Study aims




- Strategic approach to playing pitch provision.
- Robust evidence base:

 - capital funding projects.
- Basis for establishing pitch requirements arising from new housing development.
- Highlight where quality can be enhanced.
- ◀ Helps to identify where enhanced community use is needed.











- 163 football pitches in City available for community use
- Accommodate 657 teams
- ...a further 50 on school sites (currently unavailable).
- Large number: one team clubs (need links between clubs/support comm. clubs
- 60.9% of junior and 28% of senior teams play in a charter standard clubs.
- Junior/mini football continues to grow (female game & male 11-a-side decreased.
- ▼ 71% of pitches good quality, with 25% being average.
- Quality of pitches in City (and associated ancillary facilities) declining.
- 14 sites in City played beyond capacity...
- Majority of overplay attributed to sites which serve as central venue sites for minisoccer (i.e., Ford Quarry, Community North Sports Complex and Northern Area).
- Anticipated future surplus of senior pitches but...
- ...deficit of junior and mini pitches.
- Tp consider anticipated surplus of senior pitches should be considered in the context of its contribution towards addressing the deficit of junior and mini pitches.



Key challenges to address

- A large number of one team clubs need to build sustainable club entities.
- Only one Charter Standard Community Club in the City need to have full life cycle clubs.
- Only 3 senior and 3 junior female teams, and no disability teams.
- Reduce the decline of the 11 aside game.
- Security of tenure for clubs.
- Significant number of sites played over capacity.
- Teams using sites with no (or poor) changing facilities.
- Current culture of junior and youth teams not using changing facilities.
- No priority access to booking pitches.
- Perceived lack of training facilities for teams both indoor and outdoor facilities.
- Limited and sporadic use of school facilities (but some examples of good practice) – need to encourage greater use.

Proposed Actions

- Action 1: Improve the quality of facilities in the City.
- Action 2: Create and maintain sufficient facilities to meet current and future demand through identifying opportunities to add to the overall pitch stock.
- Action 3: Adopt a strategic management approach.



Proposed Actions 1 and 2

Create and maintain sufficient facilities to meet both current and future demand through identifying opportunities to add to the overall pitch stock:

- Maximise community access to all football facilities in Sunderland.
- Upgrade changing accommodation
- Reduce overplay particularly at key central venue sites

Adopt a strategic management approach to all facilities in the City to achieve the necessary increase in quality and quantity of provision:

Tiered model approach criteria to prioritise investment in strategic sites.



Moving forward: improving facilities



- Tiered development model... to improve standards & accessibility.
- Northumbria Centre & Silksworth to offer substantial indoor/outdoor training/competition opportunity.
- Investment from Russell Foster & Football Foundation in mini-soccer centre (20 pitches) enabling 3,600 juniors to play - 40 new girls' teams.
- SAFC Foundation indoor centre of excellence for learning/development through football.







Proposed tiered model..

"Balancing participation and development – giving each site a purpose."

- City to adopt an area-by-area tiered model approach to achieve strategic, consistent, timed approach to investment in facilities.
- Allow recognition of supply and demand issues & investment necessary to improve site quality.
- Ensure that development of facilities supports development of football across the City.
- Tiered model related to football development pathway.
- Tiered model defining the 'level' at which the site is to function.
