DETERMINATION OF AN APPLICATION FOR A REVIEW OF PREMISES LICENCE UNDER SECTION 52 OF THE LICENSING ACT 2003

RYE & DRY (LIFESTYLE EXPRESS), 19 RYHOPE STREET SOUTH, RYHOPE, SUNDERLAND SR2 0RN

Licensee: Miss Jeyanthy Manikkavasagar

1.0 PURPOSE OF REPORT

1.1 To consider an application for the review of a premises licence relating to the above-mentioned premises.

2.0 DESCRIPTION OF DECISION

2.1 The Sub-Committee are requested to consider the application and to take such steps as they consider appropriate for the promotion of the licensing objectives.

3.0 INTRODUCTION/BACKGROUND

3.1 An application has been received under Section 51 of the Licensing Act 2003 ('the Act') from Northumbria Police applying for a review of the above-mentioned premises licence on the grounds of the Prevention of Crime and Disorder and the Protection of Children from Harm. The application is attached as Appendix 1.

4.0 CURRENT POSITION

- 4.1 Once such an application has been received, the Council, in its role as the Licensing Authority, must advertise on, at or near the premises the fact that a review is to take place and invite representations. This notice was displayed at the premises for the statutory period of 28 days commencing on 22 November 2012.
- 4.2 Before determining the application the Council must hold a hearing to consider it and any relevant representations received.
 No representations have been received.

5.0 REASONS FOR THE DECISION

5.1 To comply with the requirements of Section 52 of the Licensing Act 2003.

6.0 ALTERNATIVE OPTIONS

6.1 None submitted.

7.0 RELEVANT CONSIDERATIONS/CONSULTATIONS

7.1 The provisions of sections 11.16 to 11.23 of the Secretary of State's Guidance (powers of a licensing authority on the determination of a review) apply to this matter.

'The 2003 Act provides a range of powers for the licensing authority which it may exercise on determining a review where it considers them appropriate for the promotion of the licensing objectives.

The licensing authority may decide that the review does not require it to take any further steps appropriate to promote the licensing objectives. In addition, there is nothing to prevent a licensing authority issuing an informal warning to the licence holder and/or to recommend improvement within a particular period of time. It is expected that licensing authorities will regard such informal warnings as an important mechanism for ensuring that the licensing objectives are effectively promoted and that warnings should be issued in writing to the licence holder.

However, where responsible authorities such as the police or environmental health officers have already issued warnings requiring improvement – either orally or in writing – that have failed as part of their own stepped approach to address concerns, licensing authorities should not merely repeat that approach and should take this into account when considering what further action is appropriate.

Where the licensing authority considers that action under its statutory powers is appropriate, it may take any of the following steps:

- to modify the conditions of the premises licence (which includes adding new conditions or any alteration or omission of an existing condition), for example, by reducing the hours of opening or by requiring door supervisors at particular times;
- to exclude a licensable activity from the scope of the licence, for example, to exclude the performance of live music or playing of recorded music (where it is not within the incidental live and recorded music exemption);
- to remove the designated premises supervisor, for example because they consider that the problems are the result of poor management;
- to suspend the licence for a period not exceeding three months;

• to revoke the licence.

In deciding which of these powers to invoke, it is expected that licensing authorities should so far as possible seek to establish the cause or causes of the concerns which the representations identify. The remedial action taken should generally be directed at these causes and should always be no more than an appropriate and proportionate response.

For example, licensing authorities should be alive to the possibility that the removal and replacement of the designated premises supervisor may be sufficient to remedy a problem where the cause of the identified problem directly relates to poor management decisions made by that individual.

Equally, it may emerge that poor management is a direct reflection of poor company practice or policy and the mere removal of the designated premises supervisor may be an inadequate response to the problems presented. Indeed, where subsequent review hearings are generated by representations, it should be rare merely to remove a succession of designated premises supervisors as this would be a clear indication of deeper problems which impact upon the licensing objectives.

Licensing authorities should also note that modifications of conditions and exclusions of licensable activities may be imposed either permanently or for a temporary period of up to three months. Temporary changes or suspension of the licence for up to three months could impact on the business holding the licence financially and would only be expected to be pursued as a necessary means of promoting the licensing objectives. So, for instance, a licence could be suspended for a weekend as a means of deterring the holder from allowing the problems that gave rise to the review to happen again. However, it will always be important that any detrimental financial impact that may result from a licensing authority's decision is appropriate and proportionate to the promotion of the licensing objectives. But where premises are found to be trading irresponsibly, the licensing authority should not hesitate, where appropriate to do so, to take tough action to tackle the problems at the premises and, where other measures are deemed insufficient, to revoke the licence.

24th September 2011

The premises were visited by a female test purchase operative under 18, who entered the store and was sold a bottle of wine by a male member of staff who did not ask for any identification. Police and Trading Standards officers then went into the store and spoke to the male who stated he was the husband of the premises owner. Further intervention was later held with the premises licence holder and Sunderland Trading Standards department.

16th February 2012

The local neighbourhood CSO attended the store and spoke to staff regarding age restricted products. The premises was also given a letter from Chief Inspector Jackson of Sunderland Area Command, the letter contained details of legislation for the restrictions on age at which alcohol and tobacco can be sold. The letter informed the premises that they could be subject of another test purchase exercise and to make sure that all staff had suitable training. This letter is attached, appendix 3.

29th October 2012

A report was received by the Police from a local resident of youths drinking in the children's play area at Beechbrooke, Ryhope. CSOs from the area stopped half a dozen teenage girls aged 14/15yrs drinking alcohol. Attached is a copy of a statement from PC 3411 JORDAN who attended the incident, appendix 1.

10th November 2012

PC 3411 JORDAN from the Sunderland East was on duty on Ryhope Street South when he identified a female he knew to be aged 16 years who had alcohol in her possession. Attached is a copy of a statement from PC 3411 JORDAN who attended the incident, appendix 2.

Please provide as much information as possible to support the application

Northumbria Police take matters of underage sales of age restricted products very seriously. Youth disorder is clearly related to the consumption of alcohol.

- Offences by youths, such as criminal damage, drunken disorderly behaviour and violence is
 often as a result of underage drinking.
- Youths under 18 are more vulnerable when drunk, particularly when they have been drinking excessively and when unsupervised as is often the case with street drinking.
- Significant public nuisance is also caused when groups of youths congregate in the Local area
 in the ready expectation of obtaining alcohol. Broken bottles, criminal damage and unruly
 behaviour by drunken youths causes distress to local residents and reduces the quality of life
 for those living in the area.

In cases where the Premises Licence Holder takes a responsible attitude in respect of promoting the Licensing Objectives, various schemes have been adopted such as 'Challenge 21 or 25' which has proved useful in tackling underage purchases of alcohol. It is our experience that youth disorder issues and underage drinking in the locality tend to reduce when the Premises Licence Holder the DPS and their staff work in partnership with the responsible authorities.

The premises have clearly demonstrated a disregard for the licensing laws and the duty to protect children from harm. It appears that the premises have already adopted a challenge 21 scheme but are not using it. The premises have CCTV but this has not acted as a deterrent to staff when they have sold alcohol to persons under 18. Officers from Northumbria Police have attended the premises on various occasions and have given advice with regards to underage sales of alcohol, which has clearly been ignored.

Research carried out by Northumbria Police and intelligence that has been received about the store reveals that it is well know by under 18s that alcohol can be easily obtained from the store. This information lead to the test purchase being carried out in September 2011 when the first sale was made. Since this date the Premises Licence Holder and DPS have not changed the way which the premises operate.

The government believes that it is completely unacceptable to sell alcohol to children and suggest that serious consideration be given to revoking a premises licence where there have been sales of alcohol to children, even in the first instance. Northumbria Police request that the Licensing Committee revoke this premises licence. This request is not made lightly but is appropriate in the circumstances, and is as a result of considerable public complaint, poor management and underage sales of alcohol at the premises.

I ascertained that he could understand very little english and asked the shop owner to translate what had said.

I checked the serial numbers of 1.5ltr bottles of Frosty Jack cider for sale in the shop which matched those seized from which have been retained in police property ref PIN8184J/12 – 01

The shop owner stated that her uncle had been covering the shop when she was having a shower.

At 7pm on Wednesday 31 October 2012 I returned to the shop and requested a copy of the store security CCTV footage of the incident on 29 October, I provided the owner with a blank VHS video tape. She has since failed to provide a copy tape.

At 6pm on Monday 5 November 2012 at Gillbridge Avenue Police Station I interviewed the defendant under caution assisted by a Tamil speaking interpreter

At 6.10pm I returned to the shop and viewed the CCTV footage, Camera 2 which showed entering the shop alone and buying the case of lager.

The shop owner on this occasion was able to provide a copy tape. (Police property Ref PIN 2749K/12 - 02)

I confirmed with the shop owner that the DPS (Dedicated Premise Supervisor) was her cousin Baskaran Mugunthan who lived in Newcastle. I then made a number of phone calls in order to speak with the DPS using telephone numbers provided by the shop owner and from Police licensing records. I failed to make contact with the DPS but did speak to a man calling himself a friend of the DPS, apparently the DPS was in London, no return date was known.

Licensing Act 2003 Children and Young Persons (Protection from Tobacco) Act 1991

The above legislation makes restrictions on the age at which alcohol and tobacco may be sold. The age for the retail sale of both alcohol and tobacco at off licence premises is 18 years. In order to test the compliance of businesses with this requirement Trading Standards and Northumbria Police recruit volunteers who attempt to purchase either alcohol or tobacco. The sale of either product to a person under 18 is an offence that could result in prosecution for the seller or the business. Between now and the end of December, Trading Standards and Northumbria Police will be conducting test purchase exercises across the Sunderland City Council area. Your premises may be one of those visited.

In relation to the Licensing Act 2003, since 1 October 2010 among the mandatory conditions added to all licenses was a condition requiring that you should have an age verification policy whereby persons appearing to be under 18 are to be challenged to produce identification bearing a photograph, date of birth and hologram. Some licenses may have conditions specifying a higher age in their conditions. It is your responsibility to ensure that all staff have had suitable training to enable them to fulfil this condition.
